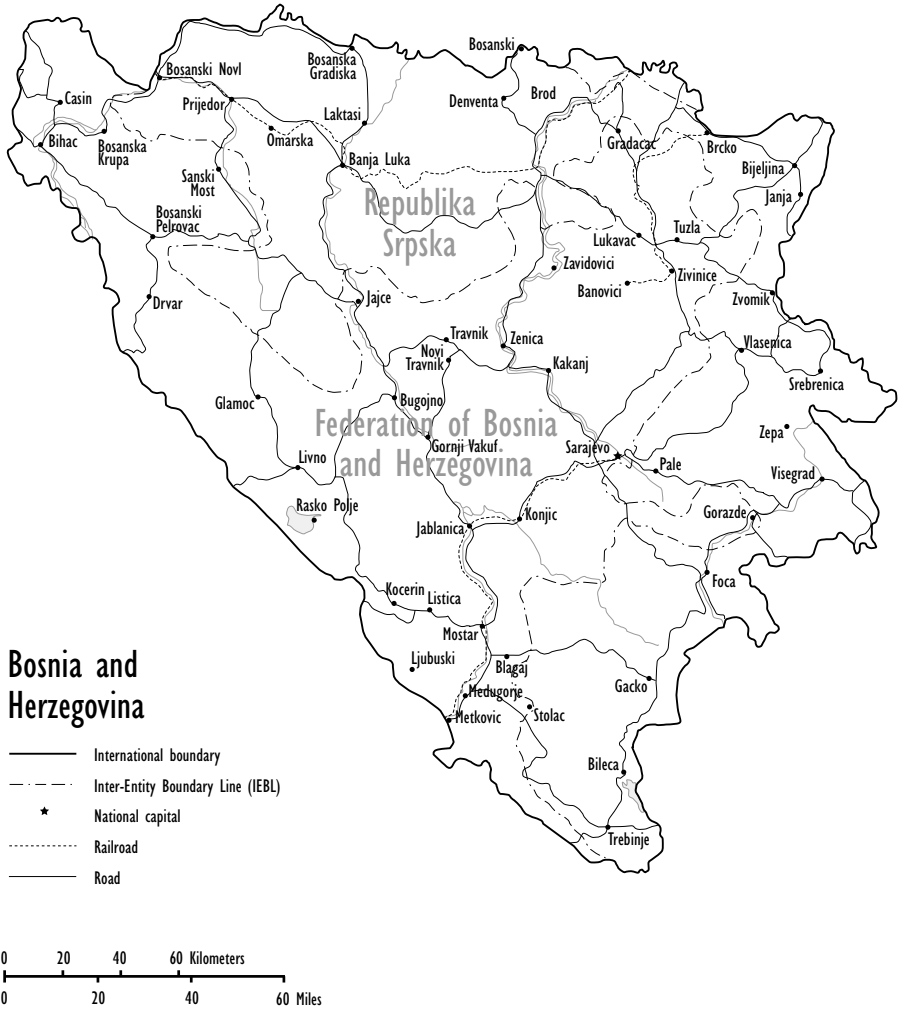

HDZ-BiH	<i>Hrvatska Demokratska Zajednica – Bosna i Hercegovina</i> . The Croatian Democratic Union – Bosnia-Herzegovina. (The Bosnian Croat nationalist party).
